THROTTLE CABLE HOUSING WEAR

TIME OF COMPLIANCE:

At next scheduled inspection or sooner if excessive

throttle cable friction is noted.

# GENERAL

On some aircraft is has been noted that more than normal wear of the throttle cable housing has occurred at the housing support in the engine compartment. To preclude this condition, a design change has been incorporated on production aircraft to firmly clamp the throttle cable housing at the housing support. The above listed aircraft serials affected may be modified to the new configuration anytime at the owner's discretion, however, the throttle cable housing must be inspected in the compliance time indicated above.

#### INSPECTION

Inspect the throttle cable housing for wear at the housing support in the engine compartment. If the throttle cable housing is worn through at any area on the locking groove, the throttle cable must be replaced.

#### NOTE

TO PERFORM THE INSPECTION NOTED ABOVE, THE THROTTLE CABLE RETAINER MUST BE REMOVED FROM THE HOUSING SUPPORT TO ALLOW VISUAL INSPECTION OF THE LOCKING GROOVE ON THE THROTTLE CABLE HOUSING.

# MODIFICATION

Service Kit No. 130, Throttle Cable Clamp Modification, has been developed and supplies the material required to modify the existing support for improved cable service life. Kits will be available through the Grumman American Dealer Organization as soon as possible. If inspection of the throttle cable housing dictates replacement, the throttle cable must be ordered separately.
